Agenda items

- 1. Approval of the Agenda Agenda of the meeting was approved as presented.
- 2. Joint Task Force on Energy Efficiency Standards in Buildings next steps Mr. Aleksandar Dukovski, Chair, welcomed the participants and informed them on the results achieved by the Joint Task Force on Energy Efficiency Standards in Buildings of the ECE Region in 2018-2019. The publication under the auspices of the Joint Task Force, scheduled to be finalized by December 2019, was highlighted. The Chair outlined the future activities as per the Group of Experts' Work Plan for 2020-2021, which was endorsed by the Committee on Sustainable Energy at its 28th session, and specifically stressed the review of Framework Guidelines for Energy Efficiency Standards in Buildings and workshops and train-the-trainer seminars on high performance energy efficiency standards in buildings in line with these Framework Guidelines. Continuation of cooperation with the UNECE Committee on Urban Development, Housing and Land Management was strongly supported. A need for additional funding was also acknowledged.
- 3. Task Force on Industrial Energy Efficiency next steps
 Mr. Stefan M. Buettner and Mr. Hannes Mac Nulty, Co-Chairs of the Task Force on
 Industrial Energy Efficiency, reported on the Task Force's activities in 2018-2019, and
 outlined further practical steps for implementing its activities for 2020-2021 (which are
 mainly subject to extrabudgetary funding), namely: identification of the key operational
 policy priorities in industry for member States and provision of platforms for collective
 action; identification of minimum industrial energy efficiency standards for important
 individual industry sectors to promote best policy practices; identification of best available
 techniques for increasing energy efficiency in industry sector in the UNECE region and
 promotion of exchange of information and data between the member States; organization
 of information sharing activities (workshops, seminars, roundtables, etc.) for exchange of
 experience on energy efficiency best practices, measures, and policies in industry, and;
 finalization of an industrial energy efficiency action plan based on the completed work
 activities. Mapping of actors in the area of industrial energy efficiency was also highlighted
 among the thematic priorities.
- 4. Practical steps for implementation of the Work Plan of the UNECE Group of Experts on Energy Efficiency for 2020-2021

 Attention was given to "Energy consumption and emissions of Electric Vehicles" activity of the Group's 2020-2021 Work Plan. Namely, possible collaboration with the UNECE Sustainable Transport Division on transport-related emissions was discussed (based on the information delivered by Ms. Alisa Freyre) concerning the potential project on developing a method for stating energy consumption / emissions of electric vehicles. The idea of establishment of a thematic joint task force was generally supported. Yet the scope of its work should be clearly specified, as the discussion featured a debate on defining 'electric vehicles', 'electric transport' and 'electric mobility', as well as on their linkages to manufacturing, policymaking, and the topic of smart cities in general. Issues related to recycling and circular economy in the context of this project were also touched.
