It is increasingly obvious to us in Ireland, see attached, and in other Member States, see for example below, that this wind energy programme is being driven without any regard to either the staggering economic cost or the hardly discernible environmental benefits (if any at all).

It is also clear that your colleagues in DG Energy have refused to accept responsibility for the proper implementation of this programme giving due regard to the Principle of Proportionality and the Aarhus Convention. This is by no means the first time they have refused to properly reply to a request related to this programme within the timeframes established by the European Code of Good Administrative Behaviour, see below:

If DG Energy are not willing to attend the meeting proposed for the 1st October, then so be it. We would rather go ahead with the meeting and exercise the option to make a communication to the compliance committee of the Aarhus Convention (<http://unece.org/env/pp/ccBackground.htm>) with regard to DG Energy's approval of the REFIT I tariffs and funding of the UK / Ireland interconnector, both of which are integral to the Irish Wind Energy Programme. A programme which has never been through the proper process of Strategic Environmental Assessment and Public Participation and for which there has been no costs / benefits review and consideration of alternatives.

Please find attached letter with regard to the above. We would be grateful for a meeting to discuss these issues and the measures proposed to resolve the current completely unacceptable situation in Ireland. The non-compliances with the Environmental Acquis are leading to huge job losses in industrial development. Furthermore the capital and operational costs of a policy of 40% of electricity to be generated by renewable sources (mostly wind based), which is neither economically or environmentally justified, cannot be sustained by this economy and will lead to ever increasing job losses in an increasingly uncompetitive manufacturing sector.
