Identification (ID) number of the TIR Carnet holder and access to the International TIR Data Bank (ITDB)

Note by the secretariat

- 1. The Administrative Committee may wish to recall that, at its previous sessions, it had urged all Contracting Parties to respect the provisions of Annex 9, Part II, paras. 4 and 5 of the Convention concerning transmission of ITDB data with a view that the ITDB becomes a value added tool for Customs authorities (TRANS/WP.30/AC.2/79, para. 18). It also stressed that it is important that Contracting Parties, if at all possible, transmit data in electronic form with a view to ensuring efficient and timely transmission and processing of data. In this context, the Committee may wish to be informed of the status of the transmission of data to the ITDB as well as the status of transmission of statutory information concerning insurance contracts, which is required at the beginning of each calendar year.
