Activities of the TIRExB

International TIR Data Bank (ITDB)

Note by the TIR secretariat

1. The ITDB contains at present information on more than 40,000 persons/companies authorized by national Customs authorities to utilize the TIR procedure and more than 20,000 persons/companies who have been withdrawn from the TIR system or have decided to end their TIR activities. It also contains information on persons excluded from the TIR procedure in accordance with Article 38 of the Convention. The information contained in the ITDB can be consulted on-line by Customs TIR Focal Points and by Customs officials provided that the national TIR Customs Focal Point has requested the TIR secretariat to authorize them.

3. In this context, the Committee may wish to be informed of the status of the transmission of legally required documentation. The following table shows the status of the transmission of data to the ITDB in compliance with Annex 9, Part II, Para. 5, and the status of transmission of statutory information concerning insurance contracts, which is required at the beginning of each calendar year.
