2. Election of officers

The Expert Group may wish to recall the signature on 6 October 2017 of a five years Memorandum of Understanding (MoU) on cooperation between UNECE and the International Road Transport Union (IRU) in the field of computerization of the TIR procedure and of the supporting Contribution Agreement (CA) towards enhancement of the full computerization of the TIR procedure.

The Expert Group may wish to take note of the progress made with regard to projects planned and launched in the framework of the MoU and CA.

(c) Progress report on the development of the eTIR international system

The Expert Group may wish to be informed about the progress made regarding the development of the eTIR international system.

4. Annex 11 of the TIR Convention

The Expert Group may wish to take note of the progress made in the development of Annex 11 (ECE/TRANS/WP.30/AC.2/2020/7) and discuss possible implications on its work. Furthermore, the Expert Group may want to consider Informal document GE.1 No. 2 (2020), presenting further clarifications about the proposal of the Russian Federation to introduce the concept of trusted third parties (TTP) in the eTIR specifications.
