3. INTRODUCTION TO PHASE II OF THE TIR REVISION PROCESS

The TIR Contact Group may wish to recall the objective behind the adopted amendments to Phase II of the TIR revision process and the procedure for their implementation.

The Group may wish to be informed about the status of the TIR Handbook. The latest version of the TIR Handbook containing all amendments to the TIR Convention entering into force on 12 May 2002 will be made available to all participants at the meeting in the English, French and Russian languages.

4. STATUS OF PHASE II OF THE TIR REVISION PROCESS

<u>Documentation</u>: ECE/TRANS/17/Amend. 21; C.N.36.2001.TREATIES-1; C.N.17.2002.TREATIES-2; C.N.123.2002.TREATIES-3; TRANS/WP.30/AC.2/59.

With Depositary Notification C.N.123.2002.TREATIES-3 the Secretary General of the United Nations has informed the Contracting Parties to the TIR Convention that the amendments contained in Depositary Notification C.N.36.2001.TREATIES-1 and adopted by the Administrative Committee of the TIR Convention in October 2002 (TRANS/WP.30/AC.2/59, Annexes 3, 5 and 7) will enter into force on 12 May 2002 as no objections has been raised. The consolidated version of all amendments under Phase II of the TIR revision process, including the amendments containing corrections to the French text contained in Depositary Notification C.N.17.2002.TREATIES-2, are contained in document ECE/TRANS/17/Amend. 21.

The Group may wish to be informed about the legal status and the entry into force of the amendments to the TIR Convention, in particular how such amendments are being implemented at national level.

5. APPLICATION OF THE REVISED PROVISIONS UNDER PHASE II

The TIR Contact Group may wish to exchange views on the application of the Recommendations adopted by the TIR Administrative Committee on 20 October 1995 and 20 October 2000 and to consider the impact of Phase II of the TIR revision process.

The Group will have before it a letter transmitted by the secretariat to all TIR Customs Focal Points on the implications of the amendments under Phase II of the TIR revision process for the IRU SAFETIR system.

The Group may also wish to be informed about the experiences made with the identification number for TIR Carnet holders and the status of the International TIR Databank (ITDB) administered by the TIR Executive Board (TIRExB).

The Group may wish to be informed by the IRU of the status of the IRU SAFETIR system.

8. OTHER BUSINESS

If time permits the Group may wish to consider any other issues of relevance for the efficient application of the TIR procedure.
