Note by the secretariat

- 1. The Harmonization Convention is a framework convention that lays down a number of key principles, which are sine-qua-non for border crossing facilitation, and provides for a high degree of flexibility in their implementation at the national level, due to the fact that there may be no 'one fits all' solution for the 55 Contracting Parties. Under this situation, examples of best practice have been found to be indispensable for the proper implementation of the Harmonization Convention. With this in mind, UNECE and OSCE have prepared and published, at the beginning of 2012, an extensive joint publication called 'Handbook on Best Practices at Border Crossings: A Trade and Transport Facilitation Perspective'. The main purpose of the Handbook is to assist countries in developing more efficient border and customs policies by promoting existing best practices in this field. It provides concrete examples from across the ECE region and beyond on how border crossing points can be made increasingly efficient and secure, thereby allowing smooth trade and transport operations while at the same time reducing the possibilities for corruption, illicit trafficking and transnational crime and terrorism.
- 2. Following the publication of the Handbook, OSCE and UNECE have started a promotion campaign which will include, inter alia, presentations at different transport and Customs related meetings as well as targeted seminars and workshops. A one-day round table on the role of best practices at border crossings in the implementation of the Harmonization Convention will be co-organised by both Organizations on 14 June 2012, in the framework of the 131st session of the Working Party. A first draft programme of the round table is reproduced below.
