Development of a GHS Roster of Experts

Transmitted by UNITAR

The GHS Action Plan adopted by IFCS Forum IV in Bangkok, Thailand in November 2003 requested UNITAR/ILO, as the focal point for capacity building in the UN SCEGHS, and in collaboration with the Sub-committee, to develop a roster of GHS experts who can provide support on training and capacity building activities on the application of GHS classification, labelling, and safety data sheets by the end of 2004. UNITAR initiated development of the roster in August 2004 through contact with the members of the UN SCEGHS. Members were also asked that if other experts would be more appropriate (e.g. from other ministries or organizations working in the agriculture, industry, transport, environment, health or other sectors), that their details should be provided.

Annex I of this document summarizes the responses received to date and provides an initial comparative analysis based on the roster of GHS experts identifying sectors, regions and areas of support where experts are willing to provide assistance.

As of 25 October 2004, 29 nominations have been received (see Annex II). Further nominations to the roster are welcome.

An initial review of the current roster reveals that:

- all nominated experts are willing to provide written input to questions related to GHS application/implementation;
- all nominated experts are willing to participate in and contribute to national/regional GHS workshops, though most indicte a need for external support;
- overall, fewer nominees have expertise in the transport and agriculture sectors than in the workplace and consumer product sectors;
- few experts are able to provide support in French in Spanish and none (currently) in Arabic, Chinese or Russian; and
- there are currently 24 experts based in developed countries and 5 based in developing countries.
