1. Introduction

The Brazilian government, through its Ministries, Agencies, Institutions and Foundations is working towards the implementation of the GHS. This task started in 2001 and since then dozens of activities were developed: national workshops, a South American Workshop, training courses, aware raising seminars, presentations in events, process for the translation of the Purple Book into Portuguese, etc.

Non-governmental organization, especially from industry, developed many activities over the last few years: organization of events, elaboration of GHS informational material, impact analysis studies, etc.

2. GT-GHS Brazil

The President of Brazil signed a Decree in 26th July 2007 formalizing the GT-GHS Working Group, which will have the responsibility to elaborate and propose strategies, guidelines, programs and plans of action.

The institutions have already nominated their representatives and the first meeting took place on 29^{th} May 2008 followed by the second on 26^{th} June, in Brasilia. The third is scheduled for 31^{th} July.

The discussions are now on the Rules and Terms of Reference. Following these tasks decisions on implementation issues will be made (revision of legislation to be in line with GHS, transitional period, Building Block Approach, etc.).

3. Training

In the second semester of 2008 the continuation of the GHS one-week training course will be planned in Rio de Janeiro or Brasilia.

4. Translation of the Purple Book into Portuguese

The process of translation of the Purple Book into Portuguese, sponsored by The Ministry of Health, is continuing.

In the first semester 2008 three meetings took place - two in Brasilia and one in Sao Paulo - for the harmonization of the translation of expressions and certain words, with the participation of more than 12 governmental and private institutions.

Translations of the chapters are in the final process of revision and will be published on the web. The printed version will be published later.

5. Workshop

The "GHS Workshop for Governmental institutions" was held in Brasilia (5th March 2008), with the participation of representatives of 12 Brazilian institutions directly involved in the implementation of the GHS – Health, Labour, Environment, Transport, Trade, Agriculture, Defense, etc -.

The ceremony was opened by the Head of General-Coordination of Health and Environmental Surveillance (Ministry of Health) and the Director of the Occupational Health and Safety Department (Ministry of Labour).
