STANDARDS

Reference to standards in Chapters 6.2 and 6.8

Note by the secretariat

The secretariat reproduces hereafter information on standards received from the representative of CEN who proposes some corrections to the text of the amendments for the 2009 edition of the RID/ADR.

If the Joint Meeting approves the proposed corrections, the dates of authorized application and mandatory application should be indicated.

1. The two references to "EN 1442:1998" in the table to 6.2.4 -for marking- and -for design and construction- should read: "EN 1442:1998 +AC:1999" to account for the corrigendum issued 1999.
2. The reference to "EN1442:2006+A1:2007" in the table to 6.2.4 -for marking- and -for design and construction- should read: "EN 1442:2006+A1:2008 due to the publication date, which will be April 2008.

Note by the secretariat: This correction was introduced in the list of amendments for ADR 2009 (ECE/TRANS/WP.15/195).

3. The reference to "EN 14025:2003" in the table to 6.8.2.6 -for all tanks- should read "EN 14025:2003+AC:2005" to account for the corrigendum issued 2005.
4. The reference to "EN 12252:2007" in the table to 6.8.2.6 -for tanks for gases of class 2- should read "EN 12252:2005 + A1:2008", because an amendment and no revision was agreed.

Note by the secretariat: This correction was introduced in the list of amendments for ADR 2009 (ECE/TRANS/WP.15/195).

5. The reference to "EN 13317:2002" in the table to 6.8.2.6 -for tanks intended for ...- should read "EN 13317:2002 + A1:2006" to account for the amendment which was supported by the standard working group in September 2006.

Note by the secretariat: This is already included in the amendments for ADR 2009 as follows. See ECE/TRANS/WP.15/195.
