NOTE 1: The terms of reference of the working group are to check draft proposals prepared by the secretariat for the harmonization of RID/ADR/ADN with the seventeenth revised edition of the UN Recommendations on the Transport of Dangerous Goods (Refer also to ST/SG/AC.10/38/Add.1 and -/Add.2) and to finalize them for submission to the September session of the Joint Meeting of the RID Committee of Experts and the Working Party on the Transport of Dangerous Goods. The main objective is to facilitate the work of the Joint Meeting and to avoid lengthy discussions on editorial matters during plenary sessions. The working group has no mandate to accept or reject the proposed amendments on behalf of the Joint Meeting.

However, for reasons of efficiency, it is recommended that only delegations who intend to contribute substantially to this editorial work participate and that their composition should be as restricted as possible.
