Draft report on the ninth meeting of the informal working group on the catalogue of questions held on 28 and 29 March 2012 in Strasbourg¹, ²

I. Participation

1. The ninth meeting of the informal working group on the catalogue of questions was held on 28 and 29 March 2012 in Strasbourg under the chairmanship of Mr. Bölker (Germany). Representatives of the following countries took part in the work of the meeting: Germany, Austria, the Netherlands and Switzerland. The following NGOs were represented: the Committee for the Prevention of Work Accidents in Inland Navigation (CIPA); European Chemical Industry Council (CEFIC); European Barge Union (EBU); and European River-Sea-Transport Union (ERSTU).

II. Adoption of the agenda

2. The agenda was adopted without amendment.

III. Programme of work

- 3. The informal working group invited the secretariat to transmit the updated programme of work to the ADN Safety Committee for adoption.
- 4. For the time being, the informal working group had agreed to use German as the working language for its meetings, but had made no provision either for interpretation or for the translation of documents. The informal working group was of the view that provision must be made for interpretation at meetings and for the translation of documents in order to allow non-German-speaking delegations to take part in the meetings.
- 5. The CCNR secretariat stated that its meeting rooms in Strasbourg, including one with four booths for interpreters, were available to ADN bodies for their meetings. Meetings of the informal working group on the catalogue of questions could therefore in principle be held in other working languages, as previously agreed in the ADN Safety Committee. The required interpreters should in that case be provided by the delegations.
- 6. On examination of the specific mandates entrusted to the Safety Committee, it appeared that the informal working group on the catalogue of questions was no longer limited to the preparation, maintenance and updating of the ADN catalogue of questions, but that it also dealt with general issues concerning the organization and quality of training and examinations. The subjects dealt with covered the whole area of training. The informal working group approved the proposition by Germany with regard to bringing its mandate up to date. Germany would make a formal request to the ADN Safety Committee.

7. The informal working group decided on amendments designed to improve and correct the ADN 2011/2013 catalogue of questions. As work could not be completed in the framework of the meeting, delegates stated that they would submit further proposals for amendments by 15 August 2012.

A. Comparison of the versions in French and German

8. The informal working group agreed to postpone consideration of the procedure for comparing the French and German versions (January 2010).

B. System of continuous adaptation of the ADN questionnaire

9. The informal working group adopted the German delegation's proposal on the establishment of a system to enable the efficient and continuous adaptation of the catalogue of questions. All questions appearing in the catalogue of questions would be reviewed and the names of the persons in charge of dealing with each question would be noted. The review work would be dated according to when the corresponding resolution of the ADN Safety Committee was taken.

C. ADN 2013

(Item 1.3 (new) of the programme of work)

10. The delegates undertook to submit their proposals on the adaptation of the catalogue of questions to ADN 2013 by 15 August 2012. They would submit proposals for the adaptation of the current catalogue of questions bearing in mind the amendments made to ADN 2011 by the ADN Safety Committee, which would enter into force on 1 January 2013. To assist with that work, the secretariat would issue the German translation of the consolidated list of amendments to the Regulations annexed to ADN (document CCNR-ZKR/ADN/18) by the end of May at the latest. The French and English versions of the document (ECE/ADN/18) were already available on the UNECE website. The secretariat would submit the consolidated list of requested amendments to the informal working group before the next meeting. It was planned to submit the updated catalogue of questions for 2013 for adoption by the ADN Safety Committee at its meeting in January 2013.

The working group reviewed the instructions for the ADN expert examination (document CCNR-ZKR/ADN/WP.15/AC.2/2011/27) and entrusted the secretariat with the task of ensuring that they were uploaded to the CCNR and UNECE websites. The review would henceforth take into account the examination objective "Stability", which would be mandatory from 1 January 2013.

It suggested rather the incorporation of questions on the subject into existing examination objectives, such as "Loading, unloading and transport" or "Hazards and measures of prevention".
- 14. The informal working group suggested increasing the number of questions in order to cover other important subjects.
- 15. The German delegation stated that it was prepared to submit its proposal to ADR experts and to provide feedback to the informal working group.
