II. Annotations and list of documents

1. Adoption of the agenda

In accordance with Chapter III, Rule 7 of the Rules of Procedure (TRANS/WP.29/690 and Amend.1) of the World Forum for Harmonization of Vehicle Regulations (WP.29), the first item on the provisional agenda is the adoption of the agenda.

2. Advanced Emergency Braking Systems

GRRF may wish to be informed on the progress made by the informal group on Advanced Emergency Braking Systems (AEBS) at its meeting prior to the GRRF session proper, especially on the performance requirements for vehicles of categories M_2 and $N_2 \leq 8$ tonnes.

3. Regulations Nos. 13 and 13-H (Braking)

(a) Electronic Stability Control (ESC)

GRRF agreed to resume consideration of revised proposals clarifying the use of a test report according to Annex 19 of UN Regulation No. 13 that proves compliance of a vehicle stability function, if available.

GRRF agreed to resume consideration of a revised proposal by the informal group on Alternative Method Electronic Vehicle Stability Control (AMEVSC) that clarifies the requirements for the use of simulations to demonstrate compliance of the vehicle stability function.

(b) Automated Connections between Vehicles (ACV)

GRRF will be informed about by the Chair of the informal group on ACV on the work progress made by the group.

(c) Clarifications

GRRF agreed to continue consideration of an updated proposal to introduce new provisions for electro-hydraulic transmission for electric brake systems.

GRRF agreed to revisit the subject of the reproduction or reference to private standards in UN Regulations and on static or dynamic references to other UN Regulations.

(d) Braking symbols in Regulation No. 121 (Identification of controls, tell-tales and indicators)

GRRF endorsed ECE/TRANS/WP.29/GRRF/2012/14 on the insertion of ESC related symbols into UN Regulation No. 121, but agreed to review the transitional provisions taking into account the guidelines by WP.29 (ECE/TRANS/WP.29/1044/Rev.1).

(e) Other business

GRRF agreed to consider a proposal tabled by the experts from the European Association of Automotive Suppliers (CLEPA) and from the International Organization of Motor Vehicle Manufacturers (OICA) to harmonize the provisions for regenerative braking systems (RBS) in UN Regulations Nos. 13 and 13-H with the Federal Motor Vehicle Safety Standards 135 (FMVSS 135) on electric vehicle requirement with special regard to the regenerative braking system.

4. Regulation No. 55 (Mechanical couplings)

GRRF may wish to consider a proposal tabled by Germany on drawbar coupling devices and their bending resistance, if available.

GRRF may wish to be informed on the work progress made by the informal group on UN Regulation No. 55. GRRF agreed to consider a proposal by the informal group on the terms of reference and rules of procedure.

5. Motorcycle braking

(a) Regulation No. 78

GRRF may wish to reconsider a proposal on motorcycle anti-lock braking systems (ABS).

GRRF may wish to consider a proposal on motorcycle braking introducing amendments to clarify the current provisions for the use of combined braking systems (CBS).

6. Regulation No. 90 (Replacement brake linings)

GRRF agreed to further discuss a proposal tabled by the expert from the Federation of European Manufacturers of Friction Materials (FEMFM) clarifying the test provisions for "identical" brake linings on the basis of a revised proposal.

7. Tyres

(a) Global Technical Regulation on tyres

GRRF agreed to have a final review of the draft Global Technical Regulation on tyres submitted by the informal group.

(b) Regulation No. 117

GRRF may consider proposals submitted by European Tyre and Rim Technical Organisation (ETRTO) amending the snow test method for C₃ tyres. GRRF may wish to consider a proposal by ETRTO for a Corrigendum to UN Regulation No. 117.

GRRF may consider proposals submitted by the experts from France and the European Commission introducing new wet grip testing provisions for tyres of category C₂ and C₃. 9. Steering equipment

(a) Regulation No. 79

GRRF agreed to reconsider a proposal submitted by the experts from CLEPA and OICA (GRRF-73-23) concerning UN Regulation No. 79, proposing the alignment of the test speed and braking performance requirement for vehicles of category M_1 and N_1 in the event of energy source failure with those in UN Regulations Nos. 13-H and 13.

(b) Lane keeping assist system (LKAS) and Parking assist systems (PAS)

GRRF agreed to revisit a proposal submitted by the expert from Japan (GRRF-73-16) suggesting possible regulatory development for "Lane Keeping Assist Systems (LKAS)" and "Parking Assist Systems (PAS)" technologies. GRRF might wish to consider a proposal submitted by the expert from Japan for the Terms of References (ToR) for a new informal group.

10. International Whole Vehicle Type Approval (IWVTA)

GRRF may expect an oral report and guidance from its Ambassador to the IWVTA Informal Group.

GRRF agreed to reconsider in detail WP.29-156-21-Rev.1 and especially the specific tasks addressed to GRRF:

- (i) GRRF may decide to create a list of suitable UN Regulations to be included in IWVTA without any or with small amendments to reach consensus.
- (ii) GRRF might decide to select potential candidate UN Regulations for IWVTA which require major amendments and might decide how to deal with these amendments.
- (iii) GRRF might consider also new possible regulatory developments (see as an example item 9(b) of this agenda and item 18 and 46 on page 5 of WP.29-156-21-Rev.1)
