# 4. Implementation of the European Agreement concerning the International Carriage of Dangerous Goods by Inland Waterways (ADN)

#### (a) Status of ADN

The Safety Committee will be informed about the status of ADN.

(b) Special authorizations, derogations and equivalents

Any proposals for special authorizations or derogations received by the secretariat will be issued in informal documents.

#### (c) Interpretation of the Regulations annexed to ADN

The Safety Committee is invited to discuss the interpretation of any provisions of the Regulations annexed to ADN which are considered to be ambiguous or unclear.

The Safety Committee may wish to propose that the interpretation of 7.2.4.16.9 which appears in paragraph 57 of the report of its last session (ECE/TRANS/WP.15/AC.2/44) be endorsed by the ADN Administrative Committee.

#### (d) Training of experts

The proposed updates to the multiple choice questions to bring them in line with ADN 2013 are presented in informal documents INF.3, 4 and 5. The Safety Committee may wish to propose that the ADN Administrative Committee adopt the revised catalogue of questions.

The guidelines for the use of the catalogue of questions for the ADN expert's examination, revised in light of comments made at the twenty-first session and the updating of the catalogue itself, are presented in document ECE/TRANS/WP.15/AC.2/2013/9.

Information on training and examinations has been transmitted by the Government of Ukraine (Informal document INF.2).

#### (e) Matters related to classification societies.

No new recognitions of classification societies have been notified to the secretariat since the last session of the Safety Committee.

#### 5. Proposals for amendments to the Regulations annexed to ADN

#### (a) Work of the RID/ADR/ADN Joint Meeting

The Safety Committee may wish to consider the draft amendments adopted by the RID/ADR/ADN Joint Meeting at its autumn 2012 session (ECE/TRANS/WP.15/AC.1/128). The Safety Committee may also wish to consider a related proposal by Germany on the exemption allowed in accordance with 1.1.3.3 of ADN (ECE/TRANS/WP.15/AC.2/2013/1).

The Safety Committee is also invited to consider any draft amendments or corrections adopted at the November 2012 session of the Working Party on the Transport of Dangerous Goods (WP.15) (ECE/TRANS/WP.15/217) which may also be relevant for ADN.
