# 2. Programme of Work

# (a) A review and analysis of the economic costs of level crossing accidents based on data provided by countries

GE.1 will consider Informal document No. 1 prepared by the subgroup comprised of Poland, United States of America (USA) and the European Railway Agency (ERA). The document contains the outcomes of the actions requested by GE.1 of this subgroup (listed below):

- To complete its analysis of the additional responses received from GE.1 members on national case studies and average or typical costs of level crossing accidents;
- Based on the information provided by these GE.1 members (if any following the Chair's request at the last session), to also analyse examples of policy decisions taken by Governments to improve the safety of level crossings where there was no compelling business case; and
- To summarize its findings to date, and to document the best practices in this area, with particular reference to the United States of America and the United Kingdom of Great Britain and Northern Ireland (UK) approaches, and the World Bank accident costs methodology.

# (b) An evaluation and analysis of the safety performance of types of level crossings in UNECE member States and in selected non-UNECE member States such as Australia, India, New Zealand and South Africa

GE.1 will consider Informal document No. 2 prepared by the subgroup comprised of France, Ireland, United Kingdom of Great Britain and Northern Ireland (UK), Community Safety Partnerships Ltd, European Railway Agency (ERA) and the International Union of Railways (UIC). The document contains the outcomes of the actions requested by this subgroup (listed below):

- To compile a list of the most suitable indicators of safety performance at level crossings taking account of existing approaches and data available in UNECE countries, and to propose the most appropriate benchmarking indicators globally;
- To identify and recommend an appropriate body or organization to collect and host the proposed indicators of safety performance at level crossings; and
- To analyse the data collected by the subgroup to date in UNECE countries including Canada and the USA, and in select non-UNECE countries such as Australia and New Zealand about the safety performance of different types of level crossings.

#### (c) A summary of good practices including education

GE.1 will consider Informal document No. 3 prepared by the subgroup comprised of Finland and India. The document contains the outcomes of the actions requested by GE.1of this subgroup (listed below):

- To circulate a table of good practices to GE.1 members and seek their feedback on types of safety improvements or good practices which have been shown to provide incremental improvement in safety levels;
- To seek information on the projects being undertaken by the UK and USA as
  mentioned at the last session in relation to educating to reduce the risks at level
  crossings, and the installation of low cost gate barriers respectively; and
- To complete the table of good practices, using information provided by GE.1 members, the UK and USA.

# (d) A survey of prevailing national legislation and/or legal arrangements at level crossings

GE.1 will consider Informal document No. 4 prepared by the subgroup comprised of Russian Federation, ERA and Instytut Kolejnictwa (Poland). The document contains the outcomes of the actions requested by GE.1 of this subgroup (listed below):

 To compile a list of good practices on national legislation including on the aspects of road speed limits and ITS communication requirements based on the information provided by GE.1 members;

- Based on the information provided by these GE.1 members (if any following the Chair's request at the last session), to also compile a list of what is or is not working well in Finland, Ireland, Italy, Poland, Sweden, UK and USA, as well as to identify important gaps in their national legislation; and
- To further consider and identify relevant amendments to the 1968 Convention on Road Signs and Signals, the 1968 Convention on Road Traffic, and the Consolidated Resolution on Road Traffic (which could be provided to GE.2 or WP.1 depending on the timing of finalization of the work of GE.1).

#### (e) A survey of technology and technological solutions to improve safety at level crossings
