I. Introduction

- 1. The report of the ADN Administrative Committee (**nr. ECE/ADN/33**) recalls that the classification societies have to provide evidence of their certification according to the standard ISO 17020:2012 (§8).
- 2. Also it is mentioned that Bureau Veritas provided evidence only for its Belgian Branch (§9).
- 3. Eventually the report requests evidence of certification that the quality system conforms with ISO 17020:2012 (§10).
- 4. The Recommended ADN Classification societies transmitted their proposal for rephrasing § 1.15.3.8 for a uniform understanding.
- 5. Notwithstanding possible misunderstanding of the requirements, the present paper aims at providing the answers of Bureau Veritas to those three topics.

II. Information

- 6. The Inland Navigation Management (DNI) of Bureau Veritas is an integral part of the Marine & Offshore Division of Bureau Veritas and benefit from a delegation from the Head Office located in Paris notably for the quality management of the inland navigation activities worldwide. Copy of the letter from EVP Marine & Offshore Division dated Sept.30, 2015 is appended. (*Annex* 6)
- 7. All the Marine & Offshore activities are subject to certification according to ISO 9001:2008 by BSI. Copy of the certificate is appended. (*Annex 4*)
- 8. Marine & Offshore Division is certified by IACS within the scope of its Quality System Certification Scheme (QSCS) which refer notably to IQMSR and ISO 17020. The letter from IACS dated Dec.23, 2015 (*Annex 8*), clarifies the approach and notably how the

IQMSR addresses the ISO 17020 standard. One copy of this letter is appended together with a copy of the statement of compliance signed by IACS. (*Annex 5*)

- 9. The Bureau Veritas Inland Navigation Management, as part of the Head Office hosted by Bureau Veritas Marine Belgium & Luxembourg N.V located in Antwerp (Belgium), benefits from an accreditation certificate according to the standard ISO 17020:2012, granted by the Belgian accreditation body BELAC. The scope of accreditation covers the services for classification of new constructions and vessels in service as well as those related to certification with regard to the main statutory regulations both for new constructions and vessels in service. Additionally to the activities of the Inland Navigation Management (DNI), the scope of accreditation mentions also the inspections carried out by the Belgian survey centre, both for classification and statutory matters. Copy of the accreditation certificate and its annex mentioning the scope are appended. (*Annexes 1 & 2*)
- 10. Although the inspections carried out by the other survey centres than Antwerp are not included in the scope of accreditation, all the surveyors involved in inspection of inland navigation vessels must follow the set of procedures laid down by the Inland Navigation Management and validated by the accreditation body Belac within the scope of the accreditation. The Inland Navigation Management (DNI) has the authority and responsibility for ensuring such compliance which is demonstrated by means of supervision, monitoring and audits. Evidence are available in procedures PAI00 and PNI01 (Annex 7) as well as in the Module A of the audit reports from Belac (Annex 3) that summarize the list of countries where the Inland Navigation Management is active. Excerpts of those documents are appended.

We have been asked to specify the current position of our Inland Navigation Management in the Bureau Veritas organisation.

According to the Regulation (EC) No 391/2009 of the European Parliament and of the Council of 23 April 2009 on common rules and standards for ship inspection and survey organisations, classification societies are called "organisations" and when recognised, comply with the definition of an organisation as follows (Article 2):

(c) 'organisation' means a legal entity, its subsidiaries and any other entities under its control, which jointly or separately carry out tasks falling under the scope of this Regulation;

Bureau Veritas carries out the classification and delegated tasks for inland vessels under *inter alia* ADN using the same lines of organisation which are put in place for marine vessels.

For reasons of language practice by the technical personnel and proximity to the main Bureau Veritas clients as well as Administrations, Antwerpen was chosen to locate the headquarters of DNI as well as "Bureau Veritas Marine Belgium & Luxembourg N.V" to host its activities.

5.1.3.2 Scope of the Inland Navigation Management (DNI)

Inland Navigation Management (DNI) is the Bureau Veritas Head Office for the Inland Navigation Activities worldwide, according to the main scope of the Marine & Offshore Division and covering classification and statutory matters of units operating on inland waterways, lakes, estuaries, maritime or semi-maritime stretches of water.

The structure dedicated to inland navigation site activities is based on the Marine & Offshore Division network

5.1.3.3 Scope of accreditation

The Belgian Accreditation Body BELAC issued the Accreditation Certificate nr. 440-INSP to Bureau Veritas Marine Belgium & Luxembourg N.V., according to the requirements of the standard NBN EN ISO/

IEC 17020:2004, for the inspections of inland navigation vessels regarding classification and statutory matters as described in the annex of the certificate which is reproduced in Annex 5.

The scope of accreditation covers the classification procedure of any vessel or structure of any type or part of it or system of vessels operated or located in inland waterways, lakes, estuaries or maritime or semi-maritime stretches of water in accordance with the Rules for the classification of inland vessels

NR217. It also includes certification according to the application of national and international regulations listed in annex of the accreditation certificate when delegated from the national authorities, i.e. the European Council Directive 2006/87/EC, the Rhine vessels inspection regulations (RVBR), the Agreement for International Carriage of Dangerous Goods by Inland Waterways (ADN) and the Belgian Royal Decree dated March 8, 2007 concerning inland vessels operated at sea for non-international voyages.

In addition to the tasks of DNI acting as the Head Office for inland navigation activities, the inspections and survey carried out by the survey center of Antwerp are also covered by the scope of accreditation.

Use of Belac logo is restricted to activities covered by the accreditation. Reference must be made to the instruction note WNI03

SECTION 8: MANAGEMENT SYSTEM

8.1 Management system

As integrant part of the Bureau Veritas Marine & Offshore Division, DNI shares the MPG Quality Policy introduced by the Marine Managing Director.

DNI activities are covered by the BSI certification of the Quality Management System as per ISO 9001:2008 (certificate FS 569502).

The Management system corresponds to the option A in § 8.1 of ISO 17020:2012.

SECTION 2: STRUCTURE DEDICATED TO NI ACTIVITIES

2.1 Structure

Inland Navigation (NI) Activities cover classification and statutory matters of units operating on inland waterways, lakes, estuaries or semi-maritime stretches of water. These activities are placed under the control of Inland Navigation Management (DNI) located in Antwerp, Belgium.


The structure dedicated to NI site activities is based on the Marine and Offshore Division network according to diagram 1 Fig.1: and diagram 1a Fig.2: hereafter.

Only exclusive surveyor may be appointed for inland navigation activities.

The Fleet Management Unit (FMU) has authority on the whole BV Survey Center network for all the inland navigation activities. The survey centers apply the DNI's procedures and they report to FMU.

The only operational activity in DNI is the Plan approval Office (APO).

2.3 Authorities of DNI

- Determine the extent, characteristics and processes of NI services.
- Determine the qualification and training necessary for NI services.
- Certify the NI Surveyors respectively for new constructions and in-service units, in compliance with the Marine Division Surveyor Certification Scheme.
- Certify the LPOs approval engineers (Local Plans Approval Offices).
- · Control the quality of services.
- Carry out internal audits of specific Units/Surveyors as necessary.
- Investigate internal complaints and those coming from clients, and decide or propose to Units, as necessary, pertinent corrective actions.
- · Provide for preventive actions.

2.4 Field network

 As a general principle, NI activities are performed by the network which operates Marine services (sea-going ships). Marine Surveyors must have the competences to carry out NI surveys. In addition to the certification scheme for sea-going vessels (Cf. PCI06 and PSI07), each surveyor must have the additional knowledge on Classification and Statutory requirements and a current practice of surveys of NI units in order to be certified as NI Surveyors by DNI.

SECTION 4 : DNI QUALITY SYSTEM

4.1 Principle

The DNIs Quality Policy is displayed in PAI00 § 6.1.

As integrant part of the Bureau Veritas Marine Division, DNI Quality System is included within the Bureau Veritas Marine Division Quality System.

The DNI Quality System complies with the Marine Division General Procedures MPGs as well as DNI own Procedures and Instructions.

4.2 DNI Quality Documentary System

 The NI activities are carried out under the guidance of the Marine Division General procedures MPGs, of the NI Rules books, of the DNI Procedures and Instructions (PNIs and TNIs) including those from the sea-going activities which have been transposed for NI activities (PSIs, PCIs, TSIs and TCIs) as well as internal working instructions notes.

SECTION 6: AUDITS OF THE NI NETWORK

6.1

Survey Centers involved in NI activities are subject to internal regional audits under the responsibility of the Regional organization, according to MPG15.

In addition, DNI conducts specific audits for NI activities. The template to be used for NC operational unit, NS operational unit and LPOs is enclosed in ANNEX A1:.

Each Center shall be audited once every three years except when it is included within the scope of the

accreditation certificate nr.440-INSP, issued by Belac with regard to ISO 17020 (Cf.PAI00 §2.4), where audit must be conducted annually.

Auditors are appointed by the DNI director or the technical director as per MPG15 and ANNEX A1 :.

For each internal auditor appointed by DNI special training regarding ISO standards 17020 is required. Records of this training are kept by Quality Manager.

Additionally, the Marine network is subject to external audits from certification bodies or flag administrations. The audit reports are recorded in the base BV MAM (action plan management) and DNI can access the findings and check they are followed-up when they concern inland navigation activities.

7.2 Monitoring of survey reports

- All survey reports shall be controlled first by SSOMs then by DNI.
 - In principle, the SSOM control rather covers the technical aspect of the survey, whereas the DNI control rather covers the administrative aspect thereof.
 - However, the SSOM should ensure that all applicable documents are sent to DNI. Similarly, DNI should clarify any technical points it may observe during its review of the documents.
- The SSOM controls, through the report, if the necessary conditions for issuance of a specific certificate or attestation are satisfactorily met. The control should cover the different items detailed hereafter:

SECTION 11: RECRUITMENT AND CERTIFICATION OF NI SURVEY-ORS

11.1 General principles

The structure dedicated to NI site activities is based on the Marine Division network (see SECTION 2 : above). Any surveyor who may be involved in inland activities must be qualified first either for NC activities, according to PCI06, or for NS activities, according to PSI07.

Only exclusive surveyor may be certified for inland navigation activities.

11.3 Validity of DNI Qualification

As a rule, validity of DNI qualifications follows the same condition than for sea-going activities. See PCI05 for LPO surveyors, PCI06 for NC surveyors and PSI07 for NS surveyors.

Supervision and monitoring must be ensured as per SECTION 5: above.

The qualification certificate may be amended or suspended by DNI. Notably, it may be automatically suspended if the corresponding qualification from C&R Compliance, for NC surveyors, or from DO-FM, for NS surveyor, is suspended.

Subject: Paragraph 1.15.3.8 of European Agreement concerning the International Carriage of Dangerous Goods by Inland Waterways (ADN) including the Annexed Regulations, applicable as from 1 January 2015, Volume I

The aim of this memo is to clarify the approach of IACS Quality System Certification Scheme (QSCS) to the EN ISO/IEC 17020 standard with respect to the included requirements in the Quality Management System Requirements (QMSR) and the requirement cited in the subject line of this memo.

Your attention is drawn to the following text contained in section 2.1.1 of QMSR, which states: "NOTE 3: REGULATION (EC) No 391/2009[†] & RO Code² refer to different versions of ISO 9001 & 17020 standards. QMSR is generally updated to reflect the currently valid versions of the ISO 9001 & 17020 standards." For EN ISO/IEC 17020, the current version of the standard (2012) is the primary basis for inclusion of the relevant requirements, mindful that the 1998 and 2004 versions are still referenced in documents of interest to classification societies and recognized organizations.

Recalling the text of ADN Requirement (Part 1, paragraph 1.15.3.8):

"The classification society shall have prepared and implemented and shall maintain an effective system of internal quality based on the relevant aspects of internationally recognized quality standards and conforming to the standards EN ISO/IEC 17020:2012 (except clause 8.1.3) (inspection bodies) and ISO 9001 or EN ISO 9001:2008 + AC:2009. The classification society is subject to certification of its quality system by an independent body of auditors recognized by the administration of the State in which it is located."

It is the policy of IACS that all member societies are independently certificated against the current version of ISO 9001 by certification bodies. Indeed ISO 9001 in its entirety is an integral part of IACS IQMSR. IQMSR also addresses parts of the ISO 17020 standard as deemed relevant by the IACS Quality Committee.

The International Standard ISO/IEC 17020 is an accreditation standard applying requirements to the inspection bodies (full name: Conformity assessment - Requirements for the operation of various types of bodies performing inspection).

Since the ISO 17020 standard is an accreditation standard and not a certification standard, the certification mentioned in the second sentence of paragraph 1.15.3.8 is understood as to imply that certification for conformance with ISO 9001 only is required, though not a formal accreditation of the classification society according to ISO 17020.

A result of the 32nd meeting of the Committee on Safe Seas and the Prevention of Pollution from Ships³ (COSS) (23 April 2014) is recalled in part as follows: "All ROs hold ISO 9001 certificates and IACS QSCS statement of compliance, but not explicitly certificate of compliance with ISO 17020. Considering that IACS QSCS requirements incorporate the ISO 9001/2008 and ISO 17020/2004 standards, the Commission and EMSA accept this situation for all ROs. The Committee took note of this information."
