GRPE may wish to consider a proposal tabled by the expert from the Russian Federation to clarify the scope of Regulation No. 83.

GRPE may wish to consider a proposal tabled by the expert from the International Organization of Motor Vehicle Manufacturers (OICA) to adapt the provisions of Regulation No. 83 on Selective Catalytic Reduction (SCR) warning and inducement systems to current vehicles, emissions requirements and reagent infrastructure.

GRPE may wish to resume discussion on the transposition process of GTR No. 15 into European Union (EU) legislation and UN Regulations.
