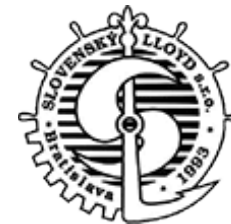

- The Non-for-Profit Organization “International Association of Technical Survey and Classification Institutions” is constituted by organizations performing activities in the field of technical survey and classification on the basis of their voluntary, equitable and mutually beneficial unification, the Constituent Agreement signed by them and TSCI Statute.



- Subject of TSCI activities is the cooperation in the field of classification and certification of inland and river-sea navigation vessels, seagoing vessels, other floating objects, technical supervision over vessels and other transport, industrial and construction objects as well as cooperation in the field of certification of management systems, manufacture, products, works and services.

# TSCI background

- Cooperation among classification bodies called TSCI began on 15th of December, 1961, when the Intergovernmental Agreement on cooperation in the sphere of technical supervision over ships and their classification was signed.
- On 17th of December 1998 the Foundation Memorandum and first Statute of TSCI were adopted.



- The Association was registered in October 07, 2002 in Moscow.
- 23 July 2015 the UN Economic and Social Council declared its decision to grant the Special Consultative Status to TSCI.

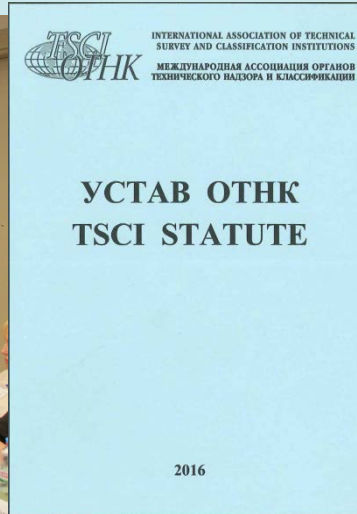
