

1. Adoption of the agenda

In accordance with Chapter III, Rule 7 of the Rules of Procedure (TRANS/WP.29/690/Rev.1) of the World Forum for Harmonization of Vehicle Regulations (WP.29), the first item on the provisional agenda is the adoption of the agenda.

2. Report on the last sessions of the World Forum for Harmonization of Vehicle Regulations (WP.29)

The Working Party on Pollution and Energy (GRPE) may agree to consider a brief oral report by the secretariat about the highlights of the March 2020 session of WP.29 on issues related to GRPE.

3. Light vehicles

(a) UN Regulations Nos. 68 (Measurement of the maximum speed, including electric vehicles), 83 (Emissions of M₁ and N₁ vehicles), 101 (CO₂ emissions/fuel consumption) and 103 (Replacement pollution control devices)

GRPE may wish to consider a proposal from the expert of the International Organization of Motor Vehicle Manufacturers (OICA) to amend the 05, 06 and 07 series of amendments to UN Regulation No. 83. The proposal aims at permitting the usage of the calibration and maintenance intervals from UN GTR No. 15 for test facilities capable of testing to that UN GTR.

(b) UN Global Technical Regulations Nos. 15 (Worldwide harmonized Light vehicles Test Procedures (WLTP)) and 19 (Evaporative emission test procedure for the Worldwide harmonized Light vehicle Test Procedure (WLTP EVAP))

GRPE may wish to consider a proposal from the IWG on WLTP for Amendment 6 to UN GTR No. 15.

GRPE will receive a status report on the activities of the IWG on WLTP.

(c) Worldwide harmonized Real Driving Emissions test procedure

GRPE may wish to consider a proposal from the IWG on Global RDE for a new UN Regulation on Global RDE.

GRPE will receive a status report on the activities of the IWG on RDE

4. Heavy duty vehicles

(a) UN Regulations Nos. 49 (Emissions of compression ignition and positive ignition (LPG and CNG) engines) and 132 (Retrofit Emissions Control devices (REC))

GRPE may wish to consider proposals to amend UN Regulations Nos. 49 and 132, if any.

(b) UN Global Technical Regulations Nos. 4 (World-wide harmonized Heavy Duty Certification procedure (WHDC)), 5 (World-Wide harmonized Heavy duty On-Board Diagnostic systems (WWH-OBD)) and 10 (Off-Cycle Emissions (OCE))

GRPE may wish to consider proposals to amend UN GTRs Nos. 4, 5 and 10, if any.

(c) Worldwide provisions for Heavy Duty vehicles Fuel Economy (HDFE)

GRPE may wish to receive a status report on the activities of harmonized provision for heavy duty vehicles fuel economy, if any.

5. UN Regulations Nos. 24 (Visible pollutants, measurement of power of C.I. engines (Diesel smoke)), 85 (Measurement of the net power), 115 (LPG and CNG retrofit systems), 133 (Recyclability of motor vehicles) and 143 (Heavy Duty Dual-Fuel Engine Retrofit Systems (HDDF-ERS))

GRPE may wish to consider a proposal prepared by the expert from OICA to amend UN Regulation No. 85. The proposal aims at permitting the usage of the gaseous reference fuels described in UN Regulation No. 83 in order to reduce potential testing complexity.

GRPE may wish to consider a proposal prepared by the expert from Liquid Gas Europe to amend UN Regulation No. 115. The proposal proposes to clarify in UN Regulation No.115 provisions for hybrid electric vehicles.

GRPE may wish to consider proposals to amend UN GTR No. 11, if any.

GRPE will receive a status report from the IWG on PMP.

8. Motorcycles and mopeds

(a) UN Regulations Nos. 40 (Emission of gaseous pollutants by motorcycles) and 47 (Emission of gaseous pollutants of mopeds)

GRPE may wish to consider proposals to amend UN Regulations Nos. 40 and 47, if any.

(b) UN Global Technical Regulations Nos. 2 (World-wide Motorcycle emissions Test Cycle (WMTC)), 17 (Crankcase and evaporative emissions of L-category vehicles) and 18 (On-Board Diagnostic (OBD) systems for L-category vehicles)

GRPE may wish to consider a proposal by the IWG on EPPR for Amendment 1 to UN GTR No. 18.

(c) Environmental and Propulsion Performance Requirements (EPPR) for L-category vehicles

GRPE will receive a status report from the IWG on EPPR.

9. Electric Vehicles and the Environment (EVE)

GRPE may wish to consider a proposal by the IWG on EVE for a new UN GTR on DEVP.

GRPE will receive a status report from the IWG on EVE.

GRPE will receive a report by its Ambassador or its Chair on IWVTA.

12. Vehicles Interior Air Quality (VIAQ)

GRPE may wish to consider a proposal to amend Mutual Resolution No. 3 (M.R.3) Concerning Vehicle Interior Air Quality (VIAQ).
