## **The Hidden Challenge**

- 1.3 million road traffic victims per year globally
- 50 million road traffic injuries per year globally
- 3000 fatalities in road crashes every day
- 10 Jumbo 747 of deaths every day
- Life long suffering
- Handicapped for life
- Disruption of families and friends

## **The Global Epidemic**

- Middle/Low income countries: + 83% traffic deaths
- High income countries: 27% traffic deaths till 2030
- Total Average: + 67%
- Middle East and North African region: + 68%
- South East Asia: + 144%
- Double disaster
- High volume and low awareness
- Great impact on quality of life
