## OUTLINE OF THE FINAL PUBLICATION ON THE NEXUS ASSESSMENT

Note prepared by the secretariat in consultation with the Chair of the Task Force on the Water-Food-Energy-Ecosystems Nexus

At its sixth session (Rome, 28–30 November 2012), the Meeting of the Parties to the Convention on the Protection and Use of Transboundary Watercourses and International Lakes requested the Task Force on the Water-Food-Energy-Ecosystems Nexus, in cooperation with the Working Group on Integrated Water Resources Management, to prepare a thematic assessment focusing on the water-food-energy-ecosystems nexus with a view to its publication prior to the seventh session of the Meeting of the Parties (see ECE/MP.WAT/37, para. 38 (i)).

The present document presents an outline of the final publication on the assessment of the water-food-energy-ecosystems nexus under the Convention. The outline and the contents have been discussed by the Task Force on the Water-Food-Energy-Ecosystems Nexus at its second and third meetings (Geneva, 8–9 September 2014 and 28–29 April 2015).

The outline will be used to structure the contents of the final publication prepared for submission to the Meeting of the Parties at its seventh session (Budapest, 17–19 November 2015) for endorsement, taking into account any comments from the Working Group.

## OUTLINE OF THE FINAL PUBLICATION ON THE NEXUS ASSESSMENT 1

The publication aims at documenting the experience acquired from the development and application of the methodology for assessing the nexus in transboundary basins, findings from the individual basin assessments as well as general conclusions and recommendations.
