Changes in the secretariat

 According to the Convention and the Protocol, the Executive Secretary of the ECE is formally the Secreta His authority is then delegated to other offiders.



- Ms. Aulavuo is on leave until 1 June 2015. Until then, Ms. Smagadi discharges her tasks. Ms. Santer continues as the Capacity Building Officer and Manager of the EaP Green programme activities

- Ms. Brunne is joining the secretariat as of 1 December for a period of six months to support the work under the Implementation Committee and capacity building





Ratifications / accessions

as of 6 November 2014

Convention: 45 Parties (including the EU) (last accession was by Malta in 2010)

First amendment entered into force on 26 August 2014

Second amendment (eight ratifications missing)

Protocol: 26 Parties (including the EU) (last ratification was by FYROM in 2013)

















The condition of the first amendment

New article 17, paragraph 3:

3. Any other State, not referred to in paragraph 2 of this Article, that is a Member of the United Nations may accede to the Convention upon approval by the Meeting of the Parties. The Meeting of the Parties shall not consider or approve any request for accession by such a State until this paragraph has entered into force for all the States and organizations that were Parties to the Convention on 27 February 2001.

- The Convention and the Protocol were represented by the Chair of the Working Group on EIA and SEA, Ms. Migle Masaityte
- In brief, the following issues were discussed:
 - Synergies among MEAs and joint activities
 - MEAs involvement at the next EfE Ministerial (2017)
 - Promotion of MEAs to other regions and implementation in countries with economies in transition
 - SD and Green economy
 - Workload, financial arrangements and sustainability of the secretariats

CEP-20 (28-31 Oct 2014)

 MEAs segment on 28 October: presentation by the secretariat on recent developments, reporting and future plans

Highlights

The CEP, inter alia:

- Welcomed the progress in promoting the benefits of the MEAs beyond the region
- Recognized the importance of the allocation of sufficient resources for the promotion of activities, and acknowledged the need to explore opportunities for mobilizing resources (e.g. through national funding, bilateral cooperation or other, as appropriate
- Recognized national implementation reporting as a valuable tool for monitoring implementation of the MEAs and welcomed the fulfilment of the reporting obligations by the majority of Parties



















Greening Economies in Eastern Neighbourhood Programme (EaP GREEN)

- A large EU funded sub-regional programme for the period **2013-2016**
- Implemented by **UNECE** (Espoo), OECD, UNEP, and UNIDO
- Benefiting countries: Armenia, Azerbaijan, Belarus, Georgia, the Republic of Moldova and Ukraine, in their transition to green economy








Overall objective: To assist the EaP countries to decouple economic growth from environmental degradation and resource depletion.

Three pillars components



UNECE Component 2 aims to promote the use of SEA and EIA as essential planning tools to achieve the overall objective







Revision of the existing national regulatory and legislative framework

- Legislative review of SEA and, as appropriate, of EIA
- Legal drafting for SEA legislation
- Sub-regional overview

Capacity building on SEA/EIA procedures

- National and subnational level training on SEA
- Development of national guidance documents
- Coordination and experience-sharing events
- Pilot SEAs and EIAs

Strengthening administrative capacities

- Legislative reviews and development of recommendations
- Policy dialogue
- Institutional reviews and recommendations

















Legislative review and technical assistance provided in tandem with practical application (pilot SEAs) and training/ awareness raising events

Armenia: assistance in drafting legislation on SEA and amending EIA

Azerbaijan: assistance in drafting legislation on EIA and SEA / pilot application of SEA

Georgia: assistance in drafting legislation on EIA and SEA

Republic of Moldova: assistance in drafting legislation on EIA and SEA /pilot application of SEA

Ukraine and **Belarus**: activities to kick off late 2014-2015
