# Systematic policy in the field of technical regulation within Customs Union

Systematic policy agreement in the field of technical regulation, sanitary and phytosanitary measures

Agreement on products circulation subject to mandatory conformity assessment (attestation) on the territory of Customs Union

Agreement on mutual recognition of accreditation of certification (conformity attestation) bodies and testing laboratories (centers) performing conformity attestation

Agreement on common principles and rules of technical regulation in the Republic of Belarus, the Republic of Kazakhstan and the Russian Federation

Establishment and application of common regulatory requirements for products Establishment of common rules of works implementation on conformity assessment

Establishment of procedure for application of technical regulation measures in relation to third countries

#### **AGREEMENT**

on common principles and rules for technical regulation in Republic of Belarus, Republic of Kazakhstan and Russian Federation

#### **Principles of technical regulation:**

- Systematic policy in the field of technical regulation
- Uniform technical regulations of the Customs union for products, included in the Uniform list of products, for which mandatory requirements within Customs Union are established
- National legislation prior entry into force of CU TRs for products, included in the Uniform list
- Establishment of mandatory requirements in national legislation in relation to the products not included in the Uniform list is not allowed

on common principles and rules for technical regulation in Republic of Belarus, Republic of Kazakhstan and Russian Federation







#### **Technical regulations of the Customs Union**

- Objectives:
  - safety
  - environment protection
  - prevention of actions misleading customers
  - energy efficiency and resources saving
- under development in relation of products, included in the Uniform list
- are approved by decision of the Commission of the Customs Union
- are of direct action on the territory of the Customs Union
- International, regional and national (intergovernmental) standards of Parties are used for meet the requirement of the Customs Union technical regulation



# UNIFORM LIST of PRODUCTS, for which mandatory requirements within the Customs Union are established

#### 61 objects of technical regulation

# on basis of EC New Approach Directives

#### low voltage equipment

- lifts
- machinery and equipment
- construction products
- toys
- personal protective equipment
- medical devices
- appliances burning gaseous fuels
- equipment operating under excessive pressure

# on basis of EC Old Approach Directives

- agricultural techniques

- On safety of low voltage equipment (Directive 2006/95/EC)
- On safety of toys (Directive 2009/48/EC)
- On safety of products intended for children and adolescents
- On safety of perfumes and cosmetics (Directive 76/768/EEC)
- On safety of packages (Directive 94/62/EC)

#### 31.12.2012

 On requirements for automobile and aviation gasoline, diesel and marine fuels, jet fuels and heating oils (Directive 98/70/EC)

#### 15.02.2013

- On safety of machinery and equipment (Directive 2006/42/EC)
- On safety of equipment for operation in explosive atmospheres (Directive 94/9/EC)

#### 18.04.2013

On safety of lifts (Directive 95/16/EC)

#### 02.08.2014

- On safety of railway rolling stock
- On safety of high-speed railway transport

# Graphic representation of the single mark for products circulation in the market of the Customs Union member-states





#### It stands for Eurasian Conformity

Ascertains that products bearing this mark have undergone all conformity assessment (attestation) procedures specified in technical regulations of the Customs Union and meet the requirements of all applicable to these products technical regulations of the Customs Union



## Decision of the Customs Union Commission on adoption of the Customs Union technical regulation

#### **ESTABLISHES**

- ✓ Date of entry into force
- ✓ List of standards for requirements implementation
- ✓ List of standards for tests
- **✓** Rules for transition period:
  - use of earlier issued documents on conformity attestation
  - application of procedures for the measurements of safety factors, for which there are no standards



# Prior the entry into force of the Customs Union technical regulations



- Types of products subject to mandatory conformity assessment (attestation)
  - Mandatory requirements (standards of the memberstates and international requirements)
    - Forms of mandatory conformity assessment (certification and declaration)
      - Common Certificates
      - Common Declarations of Conformity

Approved by CUC Decision of 7 April 2011 No. 620 (new version)

Previously issued on single form certificates of conformity and adopted declarations of conformity for products, for which the form of conformity attestation has been changed in the Uniform list, are valid till the expiry date without re-registration. Changes in labeling related to the conformity marking for such products are not required



# DEVELOPMENT AND USE OF COMMON STANDARDS FOR THE PURPOSES OF TECHNICAL REGULATIONS

### Development of common standards, related to the technical regulations of the Customs Union

Use of common standards for all the Customs Union member-states –

#### **GOST**

- For the purpose of meeting the requirements of the Customs Union technical regulation in the result of voluntary application
- For the purpose of using and fulfilling the requirements of the Customs Union technical regulation and performing conformity assessment (attestation) of products

During transitional period (prior adoption of GOSTs) national (governmental) standards of the Customs Union member-states can be used:

- GOST R
- STB
- ST RK



### DEVELOPMENT of COMMON STANDARDS, INTERRELATED with the CUSTOMS UNION TECHNICAL REGULATIONS

### Electrotechnical products

TR Safety of low voltage equipment

TR Electromagnetic compatibility of technical means

Draft list of standards (439) 85% harmonization

Necessary to develop 300 GOST based on ISO, IEC, EN, 40% from them based on ISO, IEC, EN new versions

**Toys** 

**TR Safety of toys** 

Draft list of standards (9) 90% harmonization

Necessary to develop
12 GOST based on ISO, IEC, EN,
50% from them based on ISO, IEC, EN
new versions

In addition to prepare

119 documents on the test methods
of hygienic indicators



# DEVELOPMENT AND USE OF COMMON STANDARDS FOR THE PURPOSES OF TECHNICAL REGULATIONS

- ✓ Target programs for preparation of intergovernmental standards for products, for which the technical regulations of the Customs Union are in progress
- ✓ Inclusion of standards into The Plan of EASC intergovernmental standardization
- ✓ Development of intergovernmental standards

#### Implementation of European guidelines


- to put into force mandatory at national level in every member-state of the Customs Union in a single determined deadline
- to cancel all <u>national</u> (governmental) standards that are in conflict with intergovernmental standards
- to <u>notify</u> of the beginning of <u>development</u> of <u>national</u> (governmental) <u>standards</u> and to cease their development when deciding on development of intergovernmental standards for a given object of standardization
