#### I. Mandate

- 1. This document is submitted in line with the proposed Programme Budget for 2024, part V, Regional cooperation for development, section 20, Economic Development in Europe, Programme 17, Economic Development in Europe (A/78/6 (Sect. 20), table 20.5).
- 2. At its sixty-fourth session, the Working Party on the Standardization of Technical and Safety Requirements in Inland Navigation (SC.3/WP.3) discussed the draft questionnaire for collecting information on the Application of the International certificate for Operators of Pleasure craft (ICC) towards possibly reviewing resolution No. 40 and asked the secretariat to finalize the draft based on the comments made at the session and to prepare a questionnaire for recreational boaters (ECE/TRANS/SC.3/WP.3/128), paragraphs 78 and 80).
- 3. The present document contains the questionnaires for (a) competent authorities for authorization of ICC and approved bodies for issuing of ICC, and (b) recreational boaters.
