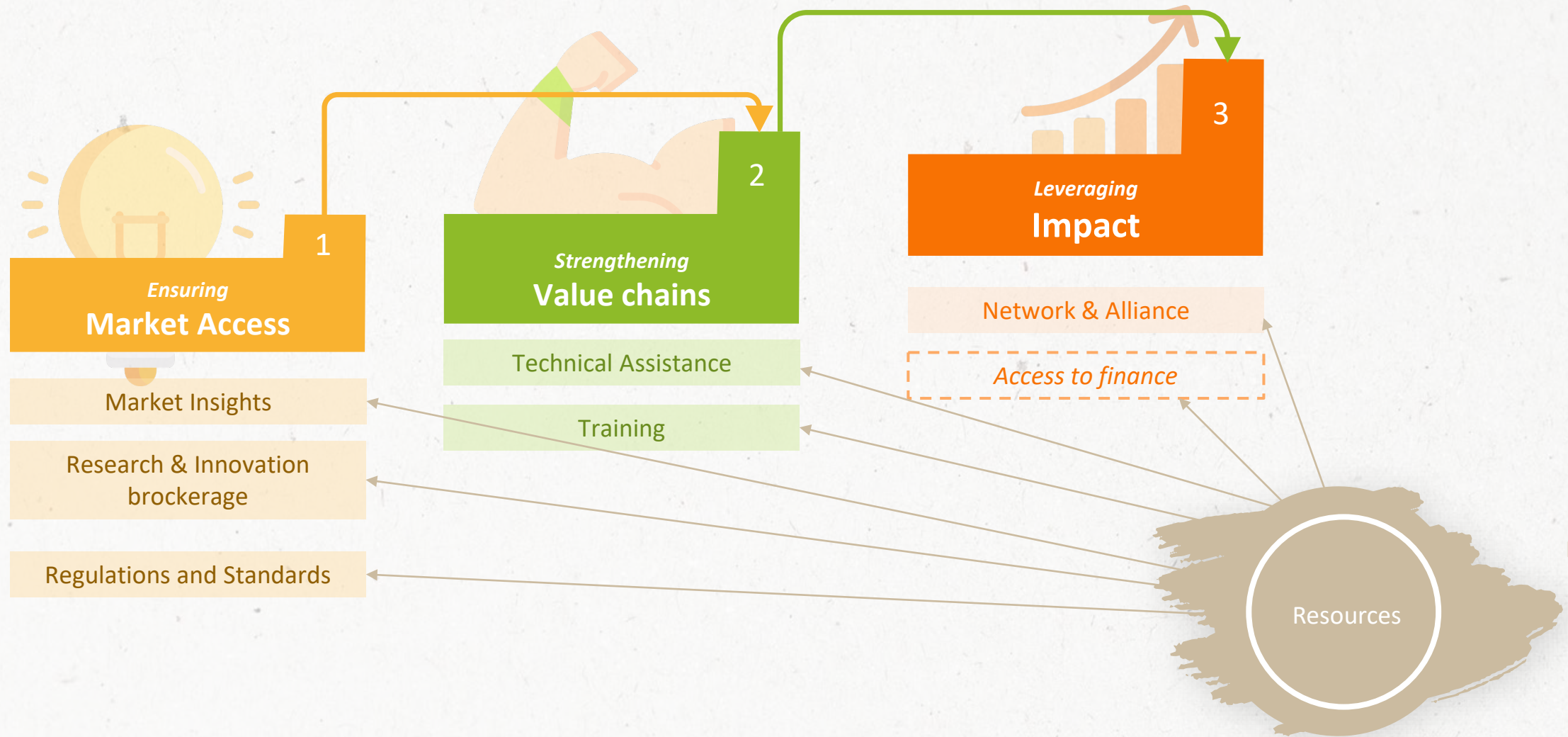

- Activities funded by **global** programmes (AGRINFO and FFM+) and **local** programmes (EUD, STDF, ENABEL, IADB,...)

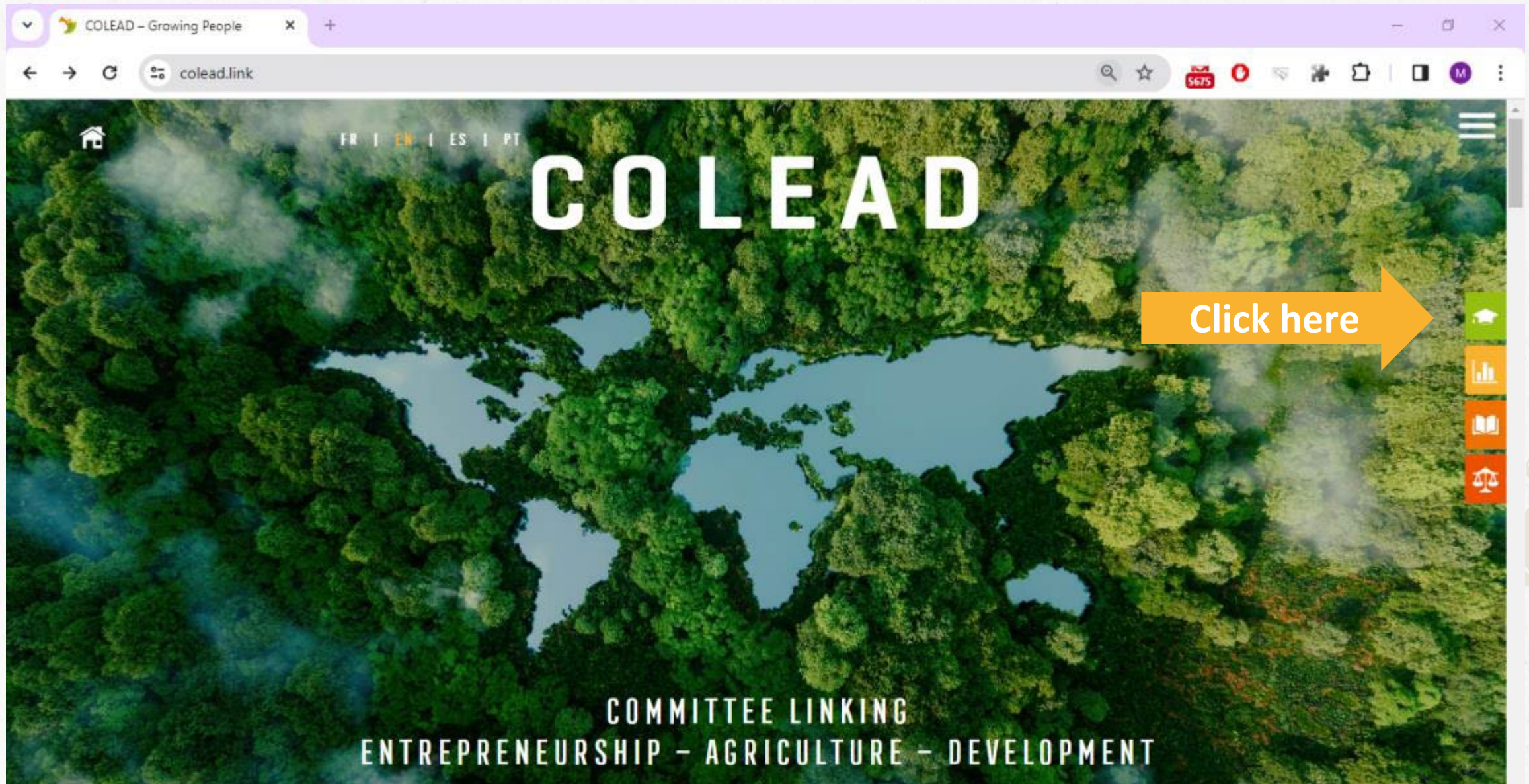

  - Disseminate this information to all relevant stakeholders

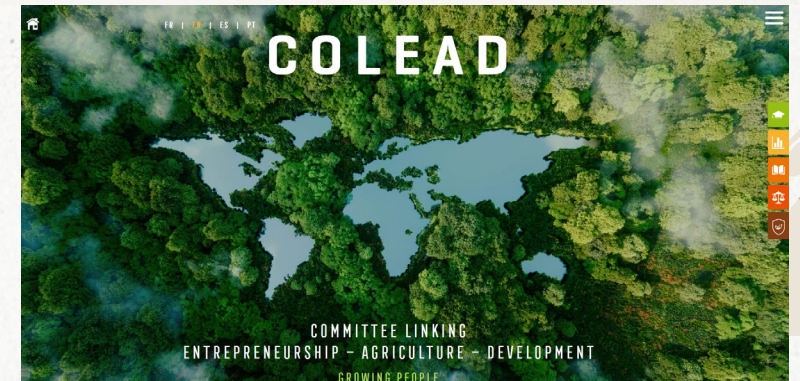
### Updates by email every 2-3 weeks + alerts:
